# **Mary Aponte**

Ms. Mary Aponte is currently a State Certified staff interpreter at the Tenth Judicial Circuit court in Bartow, Florida. She holds a bachelor's degree in Latin American Studies from the University of New Mexico. She began her pursuit of a career in court interpreting in 1996 with a Professional Certificate in Legal Interpretation and Translation from the University of California. She worked as a contract translator for Banco Popular in Puerto Rico for six years, then moved with her husband and family to Tampa in 2002. Ms. Aponte worked for the Thirteenth Judicial Circuit for nine years before switching to the Tenth Circuit. Having studied Spanish for more than 40 years, she has had the pleasure of broadening her language skills in Puerto Rico, Spain and Portugal. She speaks fluent Portuguese and has dabbled in Mandarin Chinese. She is passionate about the profession of court interpreting and strives to accelerate her own language learning and professional life, including teaching and training prospective interpreters.

# Saul Arteaga

Saul Arteaga has a bachelor's degree in Spanish and has completed classes toward a master's degree in translation studies at the University of Wisconsin - Milwaukee. He is a judiciary certified interpreter in Wisconsin and Illinois.
